Greater Boston Legal Services (GBLS) is hosting a one-year fellowship sponsored by Equal Justice Works AmeriCorps to focus on assisting elderly victims of abuse, neglect, and exploitation. The attorney selected for the Fellowship will be housed at GBLS's local office. Per Equal Justice Works/AmeriCorps guidelines, the fellowship must begin between September 1 and September 30, 2017 and last for one year.

**Fellowship Description:**

- Fellow will provide high quality legal services to older adults who have been victims of elder abuse, neglect, or exploitation. This will involve conducting intake, assembling evidence, conducting interviews and researching the relevant law.
- Fellow will create and support community elder abuse prevention coalitions of social workers, medical professionals, and law enforcement.
- Fellow will provide know your rights sessions at senior centers, assisted living communities, and other community-based settings.
- Fellow will recruit and train pro bono attorneys, through new and existing programs affiliated with the host sites.
- Fellow will collect data on the nature of the abuse and the services provided, including the indicia of abuse, the legal issue for which the client is receiving services, and the identity of the alleged perpetrators of abuse.
- The position is a one-year Fellowship.

**Qualifications:**

The ideal candidate will have the following:

- The ability to undergo and pass AmeriCorps-mandated criminal background checks (only conviction for murder and/or presence on sex offender registry are automatic bars to service; other criminal convictions are allowable at the host site's discretion);
- A demonstrated commitment to public interest work and strong desire to assist indigent clients;
- Strong writing, communication, interpersonal, and organizational skills;

- The ability to work collaboratively in a variety of contexts;
- Prior experience in managing independent projects or assignments;
- Law school clinic, externship, summer or other relevant elder law experience;
- The ability to begin the fellowship no later than September 30, 2017; and
- State bar membership or eligibility to practice in Massachusetts under limited permission rule preferred (the latter is available as a result of bar membership in another state).

### **Salary:**

The Fellow will receive annual living allowance, as well as financial support for housing, student loan repayment, and other permissible reimbursable living expenses. Additionally, Fellows receive an education award, health insurance, and other benefits. Interested applicants should contact Sonia Marquez, Director of Human Resources with any follow up questions.

### **Other Benefits Provided by GBLS:**

- Health and dental insurance provided;
- Position related travel reimbursement and bar dues provided; and
- Opportunities to participate in a variety of local and regional skills based and substantive trainings.

### **Other Benefits and Professional Opportunities offered by AmeriCorps:**

- Student loan forbearance and interest accrual payment upon successful completion of service;
- Opportunity to attend national trainings focused on leadership, networking, and project development sponsored by Equal Justice Works;
- Opportunity to attend a two-day training on elder law; and
- Childcare assistance (if income eligible).
